MEETING MINUTES

1. CALL TO ORDER

Chair Treneff called the March 31, 2021 Meeting of the Board of Trustees to order at 8:34 AM.

3. APPROVAL OF BOARD OF TRUSTEES MEETING MINUTES

Trustee Gladman motioned to approve the January 6, 2021 Special Board of Trustees Meeting Minutes. Trustee Grote seconded the motion. Motion carries.

4. COMMENTS OR STATEMENTS FROM THE PUBLIC

Mr. Walter Hardy, member of the public, made comments in relation to COTA's website, the fare management expansion project, and ERP system upgrade.











5. PRESIDENT'S REMARKS

Joanna M. Pinkerton, President/CEO of COTA, stated that this month, COTA was proud to share the 2020 Annual Report with the community. It highlighted the extraordinary accomplishments of Team COTA members during the past challenging year. COTA still provided 10.3 million trips in 2020, highlighting the need for mobility of our community. President Pinkerton noted that while the board agenda may be short, the committee reports reflect the strategic work going on behind the scenes. She also introduced Monica Jones to the Board of Trustees as COTA's first Chief Equity Officer.

6. GOVERNANCE COMMITTEE REPORT - CRAIG TRENEFF, CHAIR

Chair Treneff stated that the Governance Committee met on Wednesday, March 24. At the meeting, members heard committee reports from the committee chairs, as well as reviewed the resolutions being brought forth today.

RESOLUTION 2021-19 -AUTHORIZING AN EXTENSION OF THE EMPLOYMENT AGREEMENT WITH **EMILLE WILLIAMS**

The resolution before the Board this morning authorizes the President/CEO to enter into an extension of the employment agreement with Emille Williams, COTA's Deputy CEO. The employment agreement with Emille is also for five years, matching the term length of President Pinkerton.

Trustee Landino motioned to approve Resolution 2021-19 - Authorizing an Extension of the Employment Agreement with Emille Williams. Trustee Walker seconded the motion. Motion carries.

STRATEGIC AND OPERATIONAL PLANNING COMMITTEE REPORT – MARLON MOORE, CHAIR

Vice Chair Moore stated that the Strategic and Operational Planning Committee met on Wednesday, March 10 and had one presentation. Kim Sharp, Senior Director of Development, gave an update on the LinkUS Corridors Initiative. The East-West Corridor and Northwest Corridor are both under design phases. The East-West Corridor is slated to be submitted to the FTA in 2021, and the Northwest Corridor will be submitted in 2022.

8. EXTERNAL/STAKEHOLDER RELATIONS COMMITTEE REPORT - AMY LANDINO, CHAIR

Trustee Landino stated that the External Relations Committee met on Tuesday, March 16. There were a total of five presentations. The first was from Jeff Pullin, Public Relations Manager, on Traditional Media Metrics. COTA enjoyed an 82% increase in news coverage from 2019-2020, including significant national media coverage. Elle Paige-Sack, Marketing Consultant, presented on Earned and Paid Media Metrics, highlighting the various ways the COTA is now communicating with customers. Kim Sharp, Senior Director, Development, presented on the Columbus City School partnership, which allows 8,000 8-12th grade students to have access to COTA's transit system













until August 25, 2021. This is provided as a supplement to the CCS transportation service. Aslyne Rodriguez, Director of Government Affairs, also gave a high-level update on what is happening at the local, state, and federal levels. Lastly, Dr. Alexis Yamokoski, Chief Marketing & Experience Officer, gave a presentation on COTA's Brand Health. She highlighted the significant customer and community research conducted last year, and how that will continue into 2021.

9. PERFORMANCE MONITORING/AUDIT COMMITTEE REPORT – KUMI WALKER, CHAIR

Trustee Walker stated that the Performance Monitoring/Audit Committee met earlier that day. Angel Mumma, Chief Financial Officer, provided a financial update through February. COTA is receiving an additional \$51.6 million in 2021 CARES Act funding, bringing total funding from the federal government to over \$101 million to cover operating expenses. Operating expenses are about 2.5% below budget and with the combination of more revenue than planned and less expenses, our net operating position increased \$52 million in February. The committee also reviewed in detail the resolutions that are before the Board and recommended they all be placed on the Consent agenda.
